TASK DESCRIPTION:

The Australian legal system is based on many different sources of law and the law is constantly changing based on changing societal values and expectations.

This task requires you to research specific examples of Australian law that demonstrate the development of society over time. You will create a media file (of 3 different sources) that demonstrates your understanding of sources of contemporary Australian law. You will refer to the articles in your media file to help you respond to the following question:

Describe how the development of Australian law reflects society.

There are TWO parts to this assessment task:

- 1. Part A Media File (15 marks)
- 2. Part B Response (20 marks)

ASSESSMENT CRITERIA:

To complete this task you are to:

Complete the **TWO** parts of the assessment task. Both parts need to be submitted on Canvas by the due date.

PART A: Media File (15 marks in total – 5 marks for each media source)

You are to create a media file (of 3 sources) which meets the following criteria for each source:

- o **Identifies** the title, author, weblink and date of the source
- o Includes the complete source
- Identifies ONE source of contemporary Australian law the media source best relates to.
 This cannot be the same for each media source, therefore, your media file needs to reflect
 3 different sources of contemporary law.
- o Includes a summary of the main ideas/points of the media article (approximately 200 words for each source).

PART B: Response (20 marks)

You will use the sources in your media file (Part A), as well as any additional sources you may find, to respond to the following question: **Describe how the development of Australian law reflects society.**

You are to **apply** your understanding of the sources of contemporary Australian law to respond to the question. The question requires you to **describe** key concepts relating to the operation of the Australian legal system and over time, how the law has developed to reflect society.

Your response will:

- Incorporate appropriate legal terminology and terms
- With reference to your media examples, identify how the law has developed over time
- Consider how your selected media file examples demonstrate society's values and expectations.

Your response to the question should be approximately 1000 words and a bibliography must be included.

To answer the question successfully, you will need to conduct in-depth research, consider the directive verb and produce a well-written, well-structured and cohesive response.

You will be marked on:

- Relevancy of the media sources selected to be included in your media file
- Use of correct legal terminology to **identify** and **apply** relevant concepts and terms
- Evidence and depth of research that **describes** how different sources of contemporary law have changed over time
- Ability to **describe** the relationship between the law, and the principles and values that underpin Australian law
- Ability to communicate and organise information logically and cohesively.

USEFUL TIPS AND RESOURCES – Writing a Bibliography

A bibliography is an important means of acknowledging the sources of your information. It is important that you follow the established rules below regarding what to include in a bibliography and its correct layout.

General guidelines and information:

- keep a record of the sources you use as you go
- add your bibliography on a separately at end of your work with the heading Bibliography
- arrange items in alphabetical order according to author, or title when there is no author
- use italics for the main title
- take note of correct punctuation, as shown in examples
- Include the date on which you viewed website pages and add the URL.
- p. stands for page; pp. for pages.
