TASK DESCRIPTION:

There are two parts to this assessment task. You are required to complete and submit both parts of this task:

PART A - Fashion Portfolio (25 marks)

Students will create a fashion portfolio consisting of six (6) or more photographic images that they have created to showcase one or more fashion item/s. Students should consider lighting, shadows, backdrop/background, shot types, angle types, composition, pose, props, expression, body language, editing techniques and the elements and principles of art to communicate meaning to an audience and show case the select fashion item/s. In doing this, students will **make** their photographic images informed by an understanding of how the frames affect meaning and **make** informed choices to further develop concepts in their photographic images.

PART B - Photographer Research (10 marks)

Students will research fashion photographer Peter Lindbergh and **use** their knowledge of the photographer and the frames to complete a written response to:

"Explain how Annie Liebovitz uses structural features of a photograph to help her create emotion or mood within her images. Refer to at least 2 photographic works by Annie Liebovotz."

The written response should have an introduction, one body paragraph for each photographic work being explained and a conclusion. An Alarm scaffold is attached to help students organise their main points and evidence for their body paragraphs.

ASSESSMENT CRITERIA:

Part A – Fashion Portfolio (25 Marks)

Students will be assessed on how well they:

- Make photographic images informed by an understanding of how the frames affect meaning and make informed choices to develop and extend concepts
- Make photographic works that showcase the fashion item/s through the selection and use of highly appropriate structural features of a photograph (such as composition, shot type, angle type, lighting, elements and principles of art and editing techniques etc.)
- Make photographic works that conveys emotion, mood and meaning through the most appropriate use of photographic techniques (such as subject, lighting and shadows, shots, angles, compositions, pose, props, expression, body language and editing techniques etc.)
- Make and resolve quality photographic works

PART B - Photographer Research (10 marks)

Students will be assessed on how well they:

- **Use** aspects of the structural frame (such as signs and symbols, elements and principles of art, composition, shots, angles, techniques etc.) to explain the selected photographic images
- **Use** aspects of the subjective frame (such as memories, feelings, personal experiences, imagination, sensory experience) to explain the emotion or mood created within the photographic images
- Communicate ideas and interpretations of the selected photographic images through the **use** of the structural and subjective frames
